The first step to being considered for a space is to submit an application. Applications will be accepted after April 1, 2017.

PLEASE NOTE: Submitting an application does not guarantee a space at the Fair; do not send payment.

Once application is received, we will confirm receipt within 7-10 days. If application is accepted, a confirmation contract will be sent, payment will be due upon receiving a confirmation contract.

To Submit this application, you can download this PDF form, fill it in, save it with a new name, then email back to the appropriate contact person; or, you may print it out and mail completed form to appropriate contact person.

Inside Booth Space: Space will be in a tent or building with other merchants/vendors.

Cost/Size: \$220. for a 8 x10 or 10x10 booth space depending on the location.
