Exhibitors must purchase a Season Ticket and pay \$3.00 entry fee for each class entered. All fees must accompany entries. Entries positively close **August 24, 2018 at 4:30 PM**. Open to all counties. Animals must enter the south gate of the Fairgrounds Wednesday, September 7, between 6:00 AM and 8:30 AM for veterinary inspection. Time strictly enforced. Release time at completion of show. **Entries received day of show allowed with NO PAYBACK.**

Rules of the ADGA shall govern this show. The original registration certificate for all animals must be shown to Show Secretary prior to show. Copies will not be accepted. **No feed, pens or bedding provided.** A prep tent will be available. There will be no pre-show milk out. All animals shown in group classes must have been shown in their regular classes. Each exhibitor may enter more than two per class but only two premiums will be paid to any one exhibitor. All male goats barred from exhibit. Entries judges on merit only. All animals will be visibly healthy; inspected and dismissed at our discretion. See general rules for livestock. **No horned goats are allowed on the Fairgrounds.** If in a dehorned goat there is a regrowth of horn (scurs), which resembles a horn/horns, the animal will not be allowed on the Fairgrounds. Goats presented for exhibition must show no evidence of caseous lymphadenitis (superficial abscess), contagious exthyma (sore mouth), foot rot or any other contagious or infectious disease. These goats are not to be unloaded and cannot be shown.

Get of Sire must consist of three does from each division, the get of one sire. Best three females to consist of three does owned by the exhibitor. Goats in milk will show first in each breed.
